ANNEXURE 1

HIPSA shall be the sole custodian of the Player lists eligible to participate in any Pravasi Tournament

HIPSA will be responsible for providing Support staff (Umpires, Refrees, scorers, groundsmen, Commentators)for any Pravasi Sports Competition

HIPSA shall determine the Uniform design & Colour to be worn by Players and Support staff in Pravasi Sports Tournaments

HIPSA shall be responsible for onboarding Title Sponsors for all Pravasi Sports Tournaments

HIPSA shall determine the number of Media facing On ground Sponsorship slots to be allocated to all Organizing partners

HIPSA shall be responsible for all On-air/On ground Media rights associated with all Pravasi Sports Tournaments

HIPSA shall be responsible for all Opening/Closing/Pre/Post Match Ceremonies in the Venues where Pravasi Sports Events are held

HIPSA shall be the decision maker for all/any Venue to host Pravasi Sports Tournaments, in consultation with Organizing partners

HIPSA shall determine the Prize money to be distributed amongst winning teams of all Pravasi Sports Tournaments

HIPSA shall be the sole custodian of all VIP Passes and dignitaries to be invited to grace all Pravasi Sports Events.

Any other aspect that HIPSA believes that it should be under its purview in the interest of maintaining integrity, fairness & transparency in the Conduct of Pravasi Sports Tournaments/Leagues/Events.
